BUS PASS ELIGIBILITY	BUS SAFETY RULES
-----------------------------	-------------------------

<p>Bussing services for the Grande Prairie Catholic School District are provided by First Student Canada. To be eligible for a bus pass:</p> <ul style="list-style-type: none"> • Grade 4 – 12 students must reside 2.4 km or more from their designated boundary school. • Grade K – 3 students must reside 1.7 km or more from their designated boundary school. <p>Exceptions are:</p> <ul style="list-style-type: none"> • Students having to cross 68th Ave or 108th St • Special needs coded students attending a designated school program may be eligible upon authorization. 	<ol style="list-style-type: none"> 1. The driver is always in full charge of the bus and his/her direction must be obeyed at all times. As the driver is responsible for all the students on the bus it is essential that the driver receive respect, consideration, and co-operation from students. 2. Be at the bus stop five minutes before the scheduled stop time. 3. Line up in the safety zone and adhere to the 1 meter safety zone around the bus at all times. 4. Wait for the bus to come to a complete stop before approaching. 5. Use the handrail while boarding the bus. 6. Students must present their bus pass in order to board the bus. 7. The driver may assign specific seats at any time. 8. Students must not put any part of his/her body outside of the window. 9. Students must stay seated while the bus is in motion. 10. Students must sit facing the front of the bus. 11. Students must talk quietly as not to distract the driver. 12. The following are strictly prohibited: <ul style="list-style-type: none"> • Bullying • Scuffling • Fighting • Eating • Throwing items on the bus or out of the bus windows • Smoking/vaping • The use of obscene language • Alcohol or drugs • Firearms, knives, or weapons of any kind • Animals • Skateboards • Any type of sleds • Large items (music instruments etc) • littering 13. Skates are allowed but must be in a bag or case
BUSING FOR NON-ELIGIBLE STUDENTS	
<p>Busing may be provided for a fee to students:</p> <ul style="list-style-type: none"> • who live closer than 2.4 km from their designated school • attending a school outside of their designated boundary school <p>The following conditions must be met</p> <ul style="list-style-type: none"> • a bus must be available • a bus stop must be available • a seat on bus must be available 	
BUSING FEES **make cheques payable to Grande Prairie and District Catholic Schools**
