The advance voting station will be located at the Catholic Education Centre, 9902-101 Street, Grande Prairie

In order to vote, you must produce identification for inspection. The identification must be one or more of

- Operator/Driver's licence
- Bank/credit card statement or personal cheque
- Correspondence issued by a school, college or university
- Government cheque or cheque stub
- Income/property tax assessment notice
- Insurance policy or coverage card
- Letter from a public curator, public guardian or public trustee
- Pension Plan statement of benefits, contributions or participation
- Residential lease or mortgage statement
- Statement of government benefits: e.g. Employment insurance, old-age security, social assistance, disability support or child tax benefit
- Utility bill: e.g. Telephone, public utilities commission, television, hydro, gas or water
- Vehicle ownership registration or insurance certificate
- Attestation of Identity and Ordinary Residence for Tenant Elector issued by the authorized representative (landlord) of a commercial property management company
- Attestation of Identity and Ordinary Residence for Post-Secondary Student Elector in Residence issued by the authorized representative of a post-secondary institution
- Attestation of Identity and Ordinary Residence for Homeless Elector issued by the authorized representative of a facility that provides services to the homeless
- Attestation of Identity and Ordinary Residence for Elector in Long Term Care or Supportive Living Facility issued by the authorized representative of a supportive living facility or treatment center

(as required by section 53 of the *Local Authorities Election Act*.)
